### **POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 20 MAY 2021**

All the Proposed Resolutions as set out in the AGM Notice were duly passed by the Shareholders by way of poll at the 2021 AGM.

References are made to the circular of the Company dated 19 April 2021 (the “**Circular**”) and the notice of the annual general meeting of the Company of the same date (the “**AGM Notice**”). Capitalised terms used herein shall have the same respective meanings as defined in the Circular unless otherwise specified.

The Board of S&P International Holding Limited is pleased to announce that all the proposed ordinary resolutions as set out in the AGM Notice (the “**Proposed Resolutions**”) were duly passed by the Shareholders by way of poll at the 2021 AGM.

As at the date of the 2021 AGM, there were 1,080,000,000 issued Shares entitling the Shareholders to attend and vote for or against the Proposed Resolutions at the 2021 AGM. There were no Shares entitling the Shareholders to attend but abstain from voting in favour of the Proposed Resolutions at the 2021 AGM as set out in Rule 13.40 of the Listing Rules.

None of the Shareholders was required under the Listing Rules to abstain from voting on the Proposed Resolutions at the 2021 AGM. None of the Shareholders has stated in the Circular his/her/its intention to vote against or to abstain from voting on any of the Proposed Resolutions at the 2021 AGM.

Boardroom Share Registrars (HK) Limited, the Hong Kong branch share registrar of the Company, was appointed and acted as the scrutineer for the vote-taking at the 2021 AGM.
